Two major polygraph examiners in the Denver Metro area opened their files to the study. For each polygraph office, a random point was chosen in their 1997 client base. Each case in their files was examined to determine if the case met standards for inclusion in the sample. Selection criteria for inclusion in the sample were as follows:

- A. Sex Offender in treatment with local Sex Offender Treatment Provider.
- B. Baseline (disclosure) polygraph present in file.
- C. At least one maintenance polygraph exam present in file.

A total of 708 case files were tested for inclusion in the sample. Many did not meet all three criteria for inclusion. The final sample was as follows:
