

Computer Use Agreement for Sex Offenders

By signing below, the above named defendant/juvenile indicates (s)he understands (s)he has the right to refuse consent to the items contained herein and that the defendant/juvenile voluntarily agrees as follows: computer access to the Internet may pose significant risk of reoffense if not properly managed and the undersigned defendant/juvenile specifically agrees to be fully compliant with the following conditions:

\_\_\_\_\_ Defendant/Juvenile must obtain prior written approval from the Supervising Officer/Designee to use an electronic bulletin board system, Internet relay chat channel, DCC chat channel, Instant Messaging, newsgroup, usegroup, Peer to Peer (e.g. Napster, Gnutella, Freenet, etc.), or any site-based email which provides some measure of anonymity (e.g. Hotmail, Gmail, or Yahoo email).

\_\_\_\_\_ Defendant/Juvenile understands and agrees that using the computer for any purpose which might further sexual activity is strictly prohibited. Such use includes, but is not limited to, the following: possession of sexually explicit material in any form; sexually related "chat" or email exchange; visiting or joining "chat rooms" which contain sexually explicit conversations; visiting/viewing sexually explicit material on web sites; websites that contain nudity or sexually explicit materials; downloading binary files, UUE files, MIME files, AVI files, MPG files, Real Player files, Windows Media Files, digital images in any format, text files, or multi-media material that is sexual in nature; or visiting and/or subscribing to usegroups, newsgroups, or list servers which contain sexual content.

\_\_\_\_\_ Defendant/Juvenile agrees that (s)he shall be prohibited from possessing or viewing certain materials related to, or part of, the grooming cycle for his/her crime. Such materials include, but are not limited to, the following:

- \_\_\_\_\_ Images of your victim.
- \_\_\_\_\_ Stories or images related to your crime or similar crimes.
- \_\_\_\_\_ Images which depict individuals similar to your victims (e.g. children).
- \_\_\_\_\_ Stories written about or for individuals similar to your victim.
- \_\_\_\_\_ Materials focused on the culture of your victim (e.g. children's shows or web sites).

\_\_\_\_\_ Defendant/Juvenile agrees that (s)he shall be prohibited from using any form of encryption, cryptography, steganography, compression, password protected files and/or other method that might limit access to, or change the appearance of, data and/or images without prior written approval from the Supervising Officer/Designee . If, for work purposes, password protection is required on any system or files used by Defendant/Juvenile , that Defendant/Juvenile will provide the password upon request of Supervising Officer/Designee .

\_\_\_\_\_ Defendant/Juvenile agrees that (s)he shall be prohibited from avoiding the creation of, or altering or destroying records of computer use without Supervising Officer/Designee's approval. This includes, but is not limited to, deleting or removing browser history data regardless of its age, the possession of software or items designed to boot into RAM kernels, alter or "wipe" computer media, defeat forensic software, or block monitoring software. This also includes a prohibition against restoring a computer to a previous state or the reinstallation of operating systems.

\_\_\_\_\_ Defendant/Juvenile voluntarily consents to unannounced examination by Supervising Officer/Designee of any and all computer(s) and/or electronic devices(s) to which Defendant/Juvenile has access for the limited purpose of detecting content prohibited by this document, conditions of probation, or court order. This consent to examine includes access to all data and/or images stored on hard disks, "Zip Disks", floppy diskettes, CD ROMs, optical disks, magnetic tape and/or any other storage media whether installed within a device or removable and separate from the actual computer device.

\_\_\_\_\_ Defendant/Juvenile will provide the Supervising Officer/Designee with a current list of all equipment used by the Defendant/Juvenile and his/her computer, including back-up systems. Defendant/Juvenile will keep this list current.

\_\_\_\_\_ Defendant/Juvenile agrees to install, or allow to be installed at his/her own expense, equipment and/or software to monitor or limit computer use; The defendant/juvenile has no expectations of privacy regarding computer use or information stored on the computer if monitoring software is installed and understands and agrees that information gathered by said monitoring software may be used against him/her in subsequent court actions regarding his/her computer use and conditions of probation.

\_\_\_\_\_ Defendant/Juvenile agrees to be fully responsible for all material, data, images and information found on his/her computer at all times.

\_\_\_\_\_ Defendant/Juvenile specifically agrees and voluntarily consents that his/her computer may be examined and/or searched at any time, announced or unannounced, by Supervising Officer/Designee to verify compliance with these special conditions of supervision. The Defendant/Juvenile understands and agrees that his/her computer, related equipment, and storage devices are subject to seizure by Supervising Officer/Designee if, during an announced or unannounced examination of the computer or other media, the Supervising Officer/Designee finds any evidence of computer use prohibited by this document.
